### **Kvam herad**

- •The municipality has approx. 8500 inhabitants
- •Located 1 hour by car from Norway's second largest city, Bergen.
- •The workforce is approx. 4400.
- •Kvam is part of a living / working region with 260 000 inhabitants.
- •Kvam has a diverse business community
- •Most of the leisure activities are based on volunteer work.

## Some results ...

• As a rule, you can rely on the promises of the politicians here in the municipality ... 64,6 % believe that this statement fits quite badly

- Here in the municipality, the people elected do not abuse their power for personal benefit ... 59,4 % believe that this statement fits.
- In this municipality, the financial resources are managed in a proper manner ... 63,7 % believe that this statement fits badly.


